Joint MSc European Business and Finance

Overview

This two-year course will give you the skills you need to be a successful manager in a pan-European business environment.

Jointly designed by partner universities, you can choose to spend your first year at one of the followina:

- Brno University of Technology, the Czech Republic;
- the University of Economics, Katowice, Poland;
- the University of National and World Economy, Sofia, Bulgaria; or
- the Estonian Business School, Tallinn.

The first half of Year Two will be at Nottingham Business School, Nottingham Trent University.



Induction

A full induction programme will help you settle into the course, university and country.

Benefits

This course will:

- give you a multicultural and multilingual experience, developing your skills to communicate effectively in academic and business environments:
- promote a critical and analytical approach to information in multicultural, multilingual business situations;
- develop your ability to design and implement a research project based on the latest knowledge and practical experience of the changing European and global business environments;
- improve your career development promotion prospects;
- sharpen your awareness and understanding of the changing international context of European business and finance; and
- develop your comprehensive knowledge and understanding of a particular area of European finance.

Our partner universities for the joint MSc European Business and Finance



The University of Economics, Katowice, Poland

UEK was established in 1936 and is currently ranked in the top five economic universities in Poland. Across four faculties there are nearly 15,000 students and 494 academic staff.

The university is an active member of numerous international associations and networks and its contribution to the economic restructuring of the region has grown enormously in the last few years.

The professors of UEK have an active voice in matters concerning regional reforms, providing expertise on economic issues and conducting influential research.



The University of National and World Economy, Sofia, Bulgaria

UNWE celebrates its 100th birthday in 2019 and is the oldest higher economics school in Bulgaria and South Eastern Europe. The university has about 500 highly qualified academic staff, including 300 professors and associate professors.

Every year UNWE takes part in more than 150 national and international projects. Many of the research projects are financed by the National Scientific Research fund. Dozens of scientific events, including many international ones, take place here each year.



Brno University of Technology, the Czech Republic

BUT is the second largest technical university in the Czech Republic, and the second oldest university in the country, founded in 1899. It is ranked by the Financial Times among the top 500 universities in the world and offers Bachelors, Masters and PhD courses.

Across eight faculties, the university has 1,139 full-time academic staff, with 149 professors and 798 PhD students. BUT has a strong research portfolio: it's home to a national aerospace research centre and co-owns the Brno Centre for European Studies along with the city and six Brno universities.



The Estonian Business School, Tallinn

Founded in 1988, the Estonian Business School is the oldest private university business school in the Baltic states, offering Bachelors, Masters and Doctoral programmes in English and Estonian.

Encouraging close interaction between the 1,500 students and teachers, the School prides itself on close links to the business world, giving students academic and practical experience.

The school can be found in the centre of Tallinn, one of the best-preserved medieval European cities and also the 2011 European Capital of Culture.

Joint MSc International Finance

Overview

This two-year course helps you turn theory into practice, developing your skills and incorporating international and multicultural perspectives. A dissertation encourages you to produce applied research in an area of your interest.

Benefits

The course will help you:

- demonstrate professional management knowledge and skills;
- express yourself with confidence;
- demonstrate excellent analytical, problem-solving and numerical skills;
- give presentations with confidence in management settings; and
- develop your capacity for independent critical thought and self-directed learning.

Year One of the course takes place at the University of Economics in Bratislava (UEB), Slovakia. It is compatible with the country's magister or engineer degrees, which is a condition of the Slovak Ministry of Education for Masters level programmes .

The first half and last quarter of Year Two is also spent at UEB, with the third quarter at NTU.

At Nottingham Business School, you will join our own MSc International Finance students, leading to a more diverse and higher quality learning experience for everyone.

Induction

When you come to NTU in Year Two, we will help you settle in with a thorough induction designed to introduce you to our academic practices and processes, living and studying in the UK and the range of specialist support available.



Joint MSc International Business and Management

Overview

This two-year course, created by NTU and the University of Economics in Poznań, Poland, reflects the main strategic issues in international business and management. It will develop your knowledge and understanding and is aimed at creating managers capable of working in a multinational business environment.

The diversity at Nottingham Business School provides a stimulating atmosphere for you to learn about cross-cultural management and share different perspectives.

Benefits

This course has a growing reputation and will:

- sharpen your critical and analytical approach to multicultural business situations;
- develop your ability to design and implement a research project based on relevant knowledge of the changing international business environment;
- improve your career development and promotion prospects;
- enhance your awareness and understanding of the changing contexts of international business and management; and
- develop your comprehensive knowledge of major contemporary business issues.

Induction

To introduce you to the course and to studying and living in a different country, you will take part in a thorough induction programme.

Teaching and learning

Focused on the needs of a culturally diverse student cohort, our teaching and learning is based on the principles of:

- encouraging constructive learning through a student-centred learning environment;
- drawing upon your experiences through interactive workshops and tutorials, and not over-relying on large group lectures;
- seeing cultural diversity as a way for everyone to learn; and
- offering a range of learning experiences, including industry placements.

Admission and English language requirements

To apply, you will usually be expected to have a Bachelors in Business, Finance, Management or a related discipline.

In addition, we expect you to have:

- an ability to communicate effectively in written and spoken English within a business context;
- a willingness and ability to undertake critical academic study of international business issues;
- a willingness to develop and apply cross-cultural management skills and abilities; and
- a high level of motivation and commitment towards international business, strategy, entrepreneurship and career development.

You will normally sit an entrance exam at the University of Economics in Poznań,

There will be no standard advanced entry route for holders of a particular qualification. The final decision of acceptance and enrolment into the second year of study is made by Nottingham Business School.

City life

As a Masters student at Nottingham Business School you will experience life in a lively, cosmopolitan city situated in the heart of England. Being host to two of the UK's largest and most popular universities, Nottingham has a student population of 60,000 which means that the city is geared towards meeting your needs.

Nottingham is a stimulating place to live and study. It is a vibrant cultural centre which boasts some of the best art galleries, theatres, museums, cinemas and live performance venues in the East Midlands

Sporting interests are well catered for too, with the region offering more sporting facilities per head of population than any other European city, including international venues such as the National Water Sports Centre at Holme Pierrepont, Nottingham Tennis Centre, Trent Bridge Cricket Ground and the Capital FM Arena Nottingham.

Within Nottingham's city centre, you will find more than 1,300 retail outlets and over 350 restaurants, clubs and bars.













Culture

Nottingham is an international city of culture, in which on any given night of the week you could find yourself experiencing world cuisine, a huge variety of music, and everything from cabaret and stand-up comedy to Shakespearean theatre.

Nottingham Trent University has a long history of supporting the arts and hosts a number of major international festivals, including NOW and Sensitive Skin.

Other annual festivals and celebrations which contribute to life in Nottingham include the October Goose Fair, one of the largest and oldest travelling fairs in Europe; the August Riverside Festival; the Robin Hood Pageant; and the GameCity festival of computer gaming.

The Broadway Cinema organises a range of festivals featuring international film and other specialist subjects.

Transport links

Nottingham is an exciting city for students, with its bustling shopping areas, sites of historical interest, great entertainment venues and surrounding countryside.

It is also a major UK city close to an international airport and with excellent transport links to locations around the UK, enabling easy access to other major airports.

- East Midlands Airport is 15 miles away, half an hour from Nottingham by road.
- Manchester Airport can be accessed via the National Express coach service, which leaves for Nottingham from Terminals 1 and 2.
- From Birmingham Airport, you can take a take a taxi to New Street Station in Birmingham and then take a direct train to Nottingham.
- There is a direct coach service called Flightlink which runs every two hours from Heathrow and Gatwick Airports directly to Nottingham.

Visa / immigration requirements for non-EU residents

Once you receive an offer of a place to study at Nottingham Business School it is essential that you take the appropriate steps to ensure that you comply with the British immigration requirements for students entering the UK.

International students (non-EU) require a visa, an Entry Clearance Certificate, or a Home Office letter of consent to come and study in the UK. Application should be made to the British Embassy or British Consulate in the student's home country before coming to the UK. Nottingham Business School will supply a letter of invitation where necessary.


